Dear General Cabell:

I have talked with the Chief of Naval Personnel and understand two of your reserve officers have met his people on 25 January 1955 and have agreed to the following plan.


It appears that both your requirements and the requirements of the Navy can be met by screening the Naval Reserve officers now employed by CIA to determine those officers who will be given Navy mobilization assignments. A listing of the officers so screened should then be forwarded to the Chief of Naval Personnel in a form similar to a War Plans List modified to meet your requirements. This list should indicate name, designator, grade and desired war assignment such as to Fleet Command, Naval District or other appropriate Navy assignment along with effective date of assignment. I have requested the Chief of Naval Personnel to forward to you detailed instructions for formulating this list and to provide any other assistance in this matter.

Officers thus designated would then be eligible for training duty with pay in the same manner as all other Naval Reserve officers, with individual eligibility determined by such criteria as availability of training billets and funds for training duty, age and grade requirements.

It is patent that personnel provided appropriate Naval training should be available for mobilization. As matters now stand the Naval Reserve officers in question are excluded from all the Navy's mobilization plans consistent with the Navy's agreement with the CIA.

I am gratified for the opportunity of continued cooperation with CIA in encouraging participation by your Naval Reserve officers in Reserve affairs and I trust that the solution offered above contributes to that end.
