When I was on the West Coast last week, I ran into Vice [redacted] (Retired), a classmate of mine who presently is living in California.

[redacted] asked me what the chances were for possibly securing some connection with CIA; he undoubtedly had in mind the job that [redacted] is doing for you. I told him that I had no idea, myself, but that I would most certainly contact you on my return to Washington.

[redacted] throughout his entire active career, was considered one of the outstanding people in my class. He was a most successful officer in command at sea, he is highly qualified in technical matters, and commanded the [redacted] and his qualities of tact and diplomacy were recognized when he was assigned as the [redacted]. He is not only a man of eminently sound judgement, with ability in the executive and administrative fields, but he is also a very sophisticated and intuitive gentleman who is completely self-possessed and at home in any surroundings. Furthermore, he has been aided and abetted in life with a wife who has always enjoyed a most enviable position in any community where they have served. She, too, more than knows her way about and adds importantly to the effectiveness of the [redacted] establishment.

[redacted] was retired for physical reasons - high blood pressure. He tells me that recently, however, as a result of very effective medication, that his blood pressure is now in the area which is quite normal for blokes our age and that he is ready and quite able to do a job (I had an opportunity to personally watch him getting around on a very delightful day of dove shooting and it was quite obvious to me - even though I am a layman - that there can't be much wrong with him in view of his performance).

If you should be in the market for a mature, thoroughly forceful and competent and cultured gentleman in your business, you would be making no mistake to give serious consideration to [redacted] as a candidate.


