Dear Gen. Carter:

I consider this note to be in the public interest. You do not know me, nor I you, but that is of little importance.

I have been talking to some of the returning personnel from Europe, and since I have had a little security work in my career, the subject of guards and security always comes up. The returning men are natives of this area, well known to me, and I would venture, truthful in their comments.

I am alarmed over the apparent lack of night-time security involved in some of the missile units near the Russian line, in Germany. Quoting one man "a group of Boy Scouts, no, make it Girl Scouts, with bean-shooters, could overpower the guard or guards in the little outhouses around the perimeter in daytime, and at night, if there are any guards, I don't know about them."

I am aware that the man may not have known the security measures that had been taken. He is a missile guidance technician, and not involved in security, but in this day and age, I feel that to overlook such a comment (and he would not have made this comment except to me) would be an unnecessary risk. I know Adm. Hillenkoetter personally, and knowing the type of work that CIA has on its agenda, and that you are the Deputy Director, I felt that I should report this matter. Chances are a thousand to one that it is not a serious item, but if security is lax, on even one possible front, it would endanger us all.

If anything else ever appears, that would give me cause for alarm, I will probably report it too, so if there is a specific mailing address for such bothersome reports, you might advise me of it.
