2. It seems to me that we should notify the Agency pretty generally of the new Cuban organization headed by Cottrell, as well as to follow up on DD/P's adjustments in their own [] organization.

3. The Director is anxious that our field installations be kept constantly alerted to problem areas on which they should report, and to ensure that reporting is rapid and pertinent.

4. The Director indicated that he wanted a study, or at least an intelligence memorandum, indicating the current situation with regard to Soviet submarines.

6. The Director was anxious to see our study on "professionalism," particularly as it refers to the educational and competence level of our senior officers.


