MEMORANDUM FOR: D/BPAM

1. I spoke to Secretary Vance yesterday afternoon about the attached agreement for responsibility for equipment on loan between CIA and DOD. He understood what the problem was and was totally agreeable to having the agreement mutually worked out with Mr. Hoover. He thought it would be better (and so did I) if the new draft agreement were given to him and to me concurrently after it had been worked out at the Comptroller and Budget level and we can inject our own additional ideas, if any, at that point.

2. Please get together with Mr. Hoover and have the agreement altered in the manner we discussed yesterday. If you run into any problems, let me know soonest before a crunch develops.

Dear Mr. Secretary:

I have signed for Mr. McCone the attached agreement which provides ground rules on the financial responsibility for loss of major equipment loaned between our organizations.

The Department's proposal would seem to restrict application of paragraph one of the agreement to paramilitary operations or similar programs approved by the Special Group (Counterinsurgency). I have inserted into the agreement in place of Special Group (Counterinsurgency) the Special Group 5412/2. I believe we are agreed that the ground rules should apply to the actions authorized by the primary authority which is the Special Group 5412/2.

Paragraph two of the agreement covers all other situations where equipment is actually loaned to another agency or department. There will, of course, be occasions when equipment will be used in a joint effort without an actual loan, in which the burden of extraordinary or additional costs will have to be negotiated.
