MEMORANDUM FOR THE RECORD

SUBJECT: NRO ExCom Meeting on 14 October 1964

1. Present were Mr. McCone, Mr. Vance, General Carter, Dr. Fubini, and Dr. McMillan.


2. The first item discussed was the state of requirement for the military for U-2 coverage of Stanleyville. Various alternatives, such as RB-57's, B-47's, DC-6's, and DC-4's, were to be looked into by McMillan. CIA was to look into the possibility of getting U-2 coverage clandestinely either from a ground base or from a carrier. This matter was subsequently resolved by DOD who arranged for reconnaissance of the Stanleyville area by a C-97 based in Western Europe.

3. The second item was a discussion of [redacted] the recent CORONA failures. Dr. McMillan stated that he had talked [redacted] about making necessary changes at Lockheed to increase management capabilities. He also stated he was taking action to buck up the Air Force functions at the Lockheed plant. He did not go into details about this. He stated that the main problem with Lockheed was that there was no "Kelly Johnson" in the satellite program.




6. A discussion of the recent attempted shootdown of a Naval aircraft in the vicinity of the Hokkaido Gulf and the possibility that the shootdown may have been by an SA-2. This was still under consideration.

7. Secretary Vance said he was about to mail a letter to Mr. McCone on the proposal to send [redacted] to the West Coast. It was agreed that upon receipt of this letter, if everything seemed buttoned up, then McMillan, [redacted] Greer, and General Carter would meet on the West Coast upon General Carter's return from his Far East trip.

8. It developed subsequently that the Vance letter had too many caveats and areas for misunderstanding that would have to be negotiated, and accordingly Dr. McMillan and General Carter agreed that the negotiation should be done here in Washington and not in the presence of subordinates on the West Coast. It later developed that General Carter became sick in Honolulu and would have had to cancel the meeting anyway. The present status is that General Carter will confer with Dr. McMillan, indicating the areas that still need clarification as regards the Vance-McCone correspondence.




Recommend last sentence of paragraph 2 be reworded as follows:

"This matter was subsequently resolved by DOD who arranged for reconnaissance of the Stanleyville area by a C-97 based in Western Europe. (DCI on the morning of 15 October directed that DD/S&T not forward the U-2 information to McMillan because it was inconceivable that U-2 coverage would be permitted.)

Recommend that last sentence of paragraph 8 be revised to read:

"The present status is that General Carter will confer with Dr. McMillan, indicating the areas that still need clarification as regards the Vance-McCone correspondence."

MEMORANDUM FOR THE RECORD

SUBJECT: NRO ExCom Meeting on 14 October 1964

1. Present were Mr. McCone, Mr. Vance, General Carter, Dr. Fubini, and Dr. McMillan.

2. The first item discussed was the state of requirement for the military for U-2 coverage of Stanleyville. 
