Morning Meeting of 31 August 1965

[Redacted] of OCI provided a background briefing on Nigeria.

DDI gave a progress report on efforts to establish informal liaison with [Redacted]'s office in connection with Southeast Asia development plans. [Redacted] is on vacation and DDI will meet with him after [Redacted] return next week. (See Action item 1)
