MEMORANDUM FOR THE RECORD

Morning Meeting of 7 July 1965

Mr. Helms was in the chair -- the DCI was out of town. There was a Current Intelligence Briefing.

A/DDI noted CIA collection guides and requirement listings for current intelligence and stated the hope that State Department intelligence will endorse these lists.

A/DDI noted that ORR is in the process of issuing a memorandum reporting that Cuban nickle is appearing on the world market for the first time in five years.

[redacted] of OCI reported that office space has been made available to Peer deSilva as Vietnam Task Force Chairman. [redacted] explained that the reason for not covering the [redacted] in yesterday's President's Brief was largely because of existing OCI guidelines which are designed to prevent duplicating press reporting. He also referred to the "continuing problem" of the DIA INTSUM versus the CIB. The INTSUM is not coordinated and we do not always know what subjects will be covered.

Executive Director, in answer to Mr. Helms' query, described the DCI's concern about messages concerning [redacted] operations in Vietnam and explained that, contrary to DCI's impression yesterday, there had been no electrical transmission of the latest [redacted] information from the Pentagon to the Agency.

DDCI reported that the DCI would be absent indefinitely because of his mother's illness, and that Elder had been asked to contact Clark Clifford to explain that the DCI's Thursday and Friday appearances at the PFIAB are in question.

DDCI noted that he would be occupied most of the day tomorrow with the President's Board of Foreign Affairs Consultants who are meeting at the State Department.

DDCI inquired about the nature of Livingston Merchant's new job as Executive Director of the World Bank. It was explained that he will be Secretary of Treasury's Deputy, and representative of the U.S. Government in the World Bank. The job will take about 60% of his time. [redacted]

ACTIONS

1. DDCI approved a proposal to circulate an ORR memorandum on the current status of Bloc shipping to Haiphong. (DDI)
2. DDCI noted current news stories about the splintering of the National Liberation Front, and OCI was directed to look into this and report. (OCI)
3. DDCI requested that DDI table at some future meeting examples of the kinds of intelligence support provided to the Chairman, CAB. (DDI)
4. Noting [redacted] explanation of current guidelines for treatment of developments in the President's Daily Brief, DDCI requested that OCI submit to the DCI a paper outlining these guidelines, not only for the PDB, but other major publications as well, for DCI approval or modification. (OCI)

8. As a result of concern expressed over dissemination of advanced information on Rolling Thunder strikes in Vietnam, it was agreed that DCI, the DDCI, CIA Vietnam Task Force, and OCI would henceforth be the sole recipients of this information. (OCI)
