The Director described his meeting on 29 July with Secretary Crockett.

The Director described briefly the meeting with the PFIAB on 29 July. Bross is preparing a Memorandum for the Record on this session. The Director noted that he, General Carroll, and Tom Hughes had agreed to work out a formula to ensure that finished intelligence reports produced by intelligence agencies clearly indicate whether or not coordination was involved, and abbreviations designating producing components are to be eliminated and spelled out.

The Director described his session with the Senate Foreign Relations Committee on 29 July.
