

MEMORANDUM FOR THE RECORD

Morning Meeting of 6 July 1966

ADDI reported that Bator of the White House Staff has set up an interagency group to look into Communist grain needs over the next five years.

Godfrey noted the presence [redacted]

[redacted] Godfrey noted a Washington Post story today about the Chicom leadership. He referred to the latest Chicom monthly report which recaps current political developments, and he noted that State, OCI and ONE analysts are conferring today on Chinese developments.

Godfrey noted that Agency requirements have been made available to the Navy for use in interrogating the captured NVN sailors.

[redacted] noted an Agency cable from [redacted] recommending that contingency NIEs be made available to CINCPAC. It was noted that was a problem in the first instance for DIA rather than the Agency. DCI said it was his view that such NIEs should not be disseminated outside of the headquarters agencies in the Washington area.

[redacted] noted that there would be another meeting today of an interagency group looking into issues posed by BOB concerning space reconnaissance by NASA and NRO.

[redacted] for DDS reported that the air conditioning at the Key Building has been fixed. Damage had caused [redacted] employees to be released from work yesterday.

[redacted] reported late word that [redacted] are under custody in Saigon.

Houston reported that the Agency has been receiving transcripts of testimony pertaining to foreign research in hearings by the Harris Committee. OGC is collecting comments from various Agency components and will advise.

[redacted] reported that two staff officers from NRO will be here this morning to brief him and [redacted] on the status of [redacted].

DDP commented briefly on the [redacted] situation and theories pertaining to the reason for [redacted] ouster.

DDP noted requests from the Stations [redacted] for periodic sitreps from headquarters analysts concerning the political situation in Communist China.

DCI inquired about and was briefed on the status of OXCART deployment. Rostow is at work on a briefing paper for the President.

DCI noted a [redacted] regional broadcast pertaining to protest meetings in that area. This and other such commentary, it was agreed, should be watched carefully for any clues of [redacted] intervention [redacted].

DCI noted the lack of conclusive and detailed information relating to [redacted] advanced weapons program which was the subject of an NIE considered by USIB last week. DCI reminded all Agency components of the need to push ahead with plans and procedures to improve the state of our knowledge. This is to include efforts to keep abreast of all [redacted] relating to the subject.
