DDCI was in the chair. DCI was out of town.

DD/I noted that the CIA memo on [Redacted] had been given to Secretary McNamara yesterday, and DIA has sent the memo by cable to CINCs.

DD/I noted that he would meet to brief a [Redacted] Foreign Office official, per the request of [Redacted]. Subjects to be covered will emphasize [Redacted].

DD/I noted State Department interest in [Redacted] concerning an alleged split in the NLFSVN.

A DD/I query resulted in agreement that the DCI would be asked to sign off on an economic annex prepared by ORR to be included in JAG studies of Soviet military forces.

R. J. Smith reported pilot sightings of missiles over Laos. The suggestion of a SAM site in central Laos is open to question. Efforts are being made to determine the location of this incident.

Smith also briefed on the Indonesian situation.

DD/S reported on the status of the Agency's Suggestion and Awards Program in the past year. Of 362 suggestions, 117 were adopted. Cash awards totaled \$26,750.

At DDCI inquiry, Kent described the status of various papers to be discussed at USIB tomorrow.

At DDCI inquiry, Houston explained that most Congressmen who will be traveling to Vietnam are out of town this week, and there is not much prospect of briefing any of them for another week or so.
