I have reviewed the final report of the Joint Imagery Interpretation Review Group which has been concurrently submitted to us by our Senior Representatives and have approved the report recommendations, including the National Tasking Plan for the [redacted]

[redacted] In so doing, I have concurred in the identification of the U.S. Intelligence Board as the authority responsible for monitoring and coordinating the implementation and execution of the Plan.

Enclosed are two copies of a covering statement approving the recommendations and the Plan, which I have signed, for your approval and signature as jointly approved documents for promulgation within our respective organizations and the Intelligence Community. I am also forwarding a letter, prepared jointly for our signatures, to the Director of the Bureau of the Budget advising him of the actions taken as a result of his original proposal of 9 September 1965.

It seems desirable to me that we capitalize on the momentum gained as a result of this study, by requesting our Senior Representatives to carry on the requisite planning functions until, at an early date, the U.S. Intelligence Board instrumentality can be formally established and competently staffed.





Dear Charlie:

In response to your proposal of 9 September 1965, and in consonance with the Terms of Reference which were jointly approved on 9 October 1965, the final report of the Joint Imagery Interpretation Review Group has been completed and we have approved its recommendations.

The areas of investigation set forth in your letter have been carefully examined. Comprehensive inventories of imagery interpretation organizations serving national needs have been completed and the areas of overlap and duplication have been identified. The various requirements for departmental and national level resources have been collectively reviewed and definitive plans for tasking imagery interpretation resources on a non-duplicative basis have been devised. The approved recommendations will also provide for more effective coordination of the national and departmental research and development programs which are directed toward improving or automating imagery interpretation.

Among the major actions which will be taken are the implementation of the 'National Tasking Plan for [redacted] [redacted] the identification of the U.S. Intelligence Board as the authority responsible for monitoring and coordinating implementation of the Plan; and the adoption of a new methodology for computing uniformly the imagery interpreter resources of organizations serving national needs.

The approved time phasing schedule for implementing the Review Group's recommendations is attached. You will note that full implementation of the complete program will take considerable time and is dependent upon the availability of added funds and personnel to the CIA and the DoD for this purpose. The imagery interpretation resources required for the FY 67-71 period, however, are appreciably less than previously estimated.


