b. Emmett submitted to me a proposed set of ground rules for the Recruitment Advertising Committee. I approved but asked that they not be formalized. The key provision is that, if the Committee unanimously endorses the proposed advertisement and it is to be published [redacted] the Committee's endorsement will be final approval for publication. If the materials are to be published under acknowledged Agency sponsorship, however, they will be forwarded through the Deputy Director for Support to the Executive Director-Comptroller for final approval. Emmett then submitted three proposed ads, which I later checked out with Dick Helms. Dick approved the idea but thought that the "eye appeal" of these particular ads left a great deal to be desired. I returned them to Emmett with this advice and suggested that he obtain some professional assistance.
