1. Admiral Raborn buzzed to recommend that we consider employ-
ing or entering into some type of contract with [redacted]

[redacted] to assist us with our procurement problems. I undertook to get in touch with [redacted] and to pursue the matter. 25X1


2. I talked to Dick Helms about DD/P's request that we publish an Agency notice which in effect would say that we would not approve the retention of any staff employees who marry aliens except for the most cogent reasons. Dick was in very strong disagreement with any such action. He wants to maintain maximum flexibility in this area, judging each case on its merit and making the final decision himself. In fact, it is my opinion, based upon his attitude while DD/P as well as his expressions of today, that he will be much more lenient in approving marriage to aliens than were either General Cabell or General Carter.

3. Bud Wheelon asked my advice about recommending [redacted] for an Agency medal. I suggested that we not do this. 25X1

4. At Dick Helms' request I talked with him again about my recent memorandum which he had approved on manpower and organization controls. He seemed completely convinced that the memorandum did express the proper Agency policy. He asked to keep the memorandum for a day or two, but I did not detect any inclination to back down on the position which he previously supported.

5. I was briefed by [redacted] and other DD/I people on Project CHIVE. Their feelings are considerably hurt because in the Fiscal Year 1967 budget we did not allow them space and money for [redacted] additional people (including [redacted] for OCS). However, they have [redacted] vacancies and I doubt that they can recruit the kind of people they need in excess of this number. In addition, I thought that their program was not well thought through. What it needs is a good systems analysis setting forth the problem, what will happen if we don't go forward with CHIVE, what it means for the long term, how fast it will replace existing systems in the Office of Central Reference, and the eventual product and cost. I urged them to prepare such a program.

6. I spent an hour with John Clarke and his people discussing our integrated planning-programming-budgeting system and cycle in preparation for our briefing of the Director at 1100 hours tomorrow.

7. Bob Bannerman reported that [redacted] formally the head of our JOT Staff and now a JOT recruiter [redacted] has cancer of the throat which is apparently in a fairly advanced stage.

8. In a discussion with [redacted] about his plans, I learned that he is to replace [redacted] and that he understood [redacted] was going to work for John Clarke. I checked with John who said that [redacted] had been offered to him but that he had declined to accept him. In this connection, I picked up bits and pieces to indicate that, while [redacted] will be age 65 on 1 January 1966, there is some move afoot to continue him on duty notwithstanding the fact that the DD/P doesn't seem to really need him. I discussed this with Dick Helms who expressed himself very strongly in favor of living up to the spirit of our retirement policy. He also said that in [redacted] case he had signed some paper which made a commitment to [redacted] and which he remembered to be one year after his return from [redacted]. Dick asked me to find this paper, and I asked [redacted] of the WH Division for it. I think that Dick feels that [redacted] should not be extended beyond that date.
