MEMORANDUM FOR: Director of Central Intelligence

SUBJECT : Separation of Personnel Surplus to the Technical Services Division, DD/P

REFERENCES : (a) Memo from DD/P to DCI, dated 21 March 1961, subject: Curtailment of the Reproduction Capabilities of the TSD
 (b) Memo from Acting DD/P to D/Pers, dated 1 June 1961, same subject as reference (a)
 (c) Memo from DD/P to D/Pers, dated 5 July 1961, same subject as reference (a)

1. This memorandum contains a recommendation for your approval. Such recommendation is contained in paragraph 6.

2. Pursuant to the provisions of Regulation [] "Separation of Surplus Personnel", the Deputy Director (Plans) in a memorandum dated 21 March 1961 [Reference (a)] requested that you approve action to reduce by approximately three the personnel strength of the Special Reproduction Section, Graphic Arts Reproduction Branch, Technical Services Division, DD/P. Following your approval of this request on 27 March 1961, action was taken in accordance with Regulation [] to identify those individuals who should be proposed for separation as surplus to the requirements of the Section concerned.

3. In a memorandum to me dated 1 June 1961 [Reference (b)] the Acting Deputy Director (Plans) set forth his determination that there is a surplus of three individuals in the Special Reproduction Section and recommended that the following three persons, who are ranked lowest on the pertinent Relative Retention List, be separated:

[] - DOB: 7 July 1906; EOD with CIA: 4 August 1952; total Government service (as of 1 August 1961): 27 years, 10 months; current annual salary: \$11,398.

[] - DOB: 18 October 1910; EOD with CIA: 14 September 1953; total Government service (as of 1 August 1961): 20 years, 3 months; current annual salary: \$10,504.

[] - DOB: 16 May 1893; EOD with CIA: 30 August 1948; total Government service (as of 1 August 1961): 14 years, 6 months; current annual salary: \$11,044.

4. Pursuant to Regulation [] I have determined that the prescribed procedures have been complied with and that the individuals named in the preceding paragraph have been identified in accordance with the provisions of the Regulation. The pertinent Relative Retention List, submitted by the Head of the Clandestine Services Career Service, has been reviewed by a Review Committee as well as by myself and no changes in the ranking have been recommended. I have also determined that there are no vacant positions elsewhere in the Agency to which any of the individuals named in the preceding paragraph may be retained in Agency employment through reassignment.

5. Pursuant to the provisions of Regulation [] "Separation Compensation", the Acting Deputy Director (Plans) has also recommended that Messrs. [] and [] if separated in accordance with the provisions of Regulation [] be granted separation compensation. The Deputy Director (Plans) has indicated in his memorandum dated 5 July 1961 [Reference (c)] that the Agency service of both [] and Mr. [] was of such a nature as to prevent them, for reasons of operational security, from describing or confirming to a prospective employer the scope and level of their duties and responsibilities. The third individual named above, [] is not eligible for such compensation under the provisions of Regulation [] in view of the fact that he is currently eligible for an optional retirement annuity without reduction by reason of age. I have reviewed the nature and circumstances of the assignments of Messrs. [] and [] in consultation with representatives of the Clandestine Services Career Service and am of the opinion that the payment of the maximum Separation Compensation Allowances in both instances is consistent with the provisions of Regulation []
