PRESENT: General Smith, Messrs. Dulles, Wisner, Becker, Col. White, [redacted]

General Smith:

25X1 a. Discussed certain information received concerning [redacted] and the [redacted] and asked whether this information had been confirmed and what we were doing about it. Mr. Wisner noted that [redacted] were investigating this matter and there appeared to be a possibility that [redacted] might go out of existence. The Director said he desired to [redacted] has hard as possible." 25X1 25X1 25X1

b. Referred to SE 30 and, after some discussion, asked Mr. Becker whether this estimate had been disseminated. Mr. Becker stated that it had and would be available to the NSC Senior Staff at its meeting this afternoon.

Mr. Dulles:

25X1 a. Referred to an article in the [redacted] concerning [redacted] and stated we should get a report of her visit as soon as possible. Mr. Wisner noted there were a number of major propaganda points contained in the above-mentioned article which should be exploited. After some discussion, Mr. Dulles stated that possibly [redacted] could personally see [redacted] when he arrives in [redacted] since he preferred, if possible, to get her report first hand. Mr. Wisner undertook to follow through on this. 25X1 25X1

b. Noted that the so-called Princeton Paper on U.S. Policy Toward the Satellites was coming up for discussion at the PSB meeting to be held on Thursday, 12 June, and stated that he felt we should push this along. S-6-12-52

25X1 c. Stated that [redacted] had recommended a change in the wording of the NSC 10/5 "Packet Paper" and that this might also be discussed at the PSB Meeting on 9 June. The Director said that (1) [redacted] had discussed this proposed change with him at some length and that he (the Director) was not sure from the wording who was to audit who; (2) if Defense was to audit the scope of our programs, the answer was "no"; (3) there was, of course, no objection to Defense auditing their own resources and capabilities and so notifying us in order that we could plan our programs accordingly. 25X1 d. Raised the matter of another visit to the U.S. by [redacted] or another [redacted] representative and, after some discussion, the Director stated there was nothing further for us to do until we heard from [redacted] 25X1

e. Noted that the so-called [redacted] was back on the track.

f. Gave the Director a cable concerning [redacted] and, after some discussion, the Director stated that no further distribution should be given this cable with the exception that (1) a sanitized copy be sent to Mr. Armstrong for the Secretary of State; (2) a similar copy be placed in the President's book for Friday, 13 June. (NOTE: After the meeting this matter was discussed with [redacted] who undertook to make distribution as indicated above.)

Mr. Wisner:

a. Stated that the [redacted] operation went off successfully and the Director's admonition concerning the "publicity" given this operation had been administered.
