Mr. Dulles:

a. Asked for suggestions to effect complete coordination within the Agency in regard to Stalin's illness. Mr. Wisner noted that [redacted] were personally working on the problem and discussions had been held with [redacted] of PSB and in some instances representatives of the Department of State. Mr. Becker gave the Director a memorandum from [redacted] and the [redacted] on this subject, and after some discussion Mr. Dulles asked that: (1) sufficient copies of this memorandum be prepared for dissemination to the members of PSB at today's luncheon; (2) DD/P provide him with a one-page memorandum outlining what "we think" of the Stalin situation; (3) a small committee be established composed of representatives from ONE, OCI and DD/P, to pull together and organize information on the "Stalin Situation"; (4) consideration be given to dispatching cables [redacted] giving them policy guidance in connection with Stalin and noted that he (DCI) would in all probability have further ideas on this after today's PSB Luncheon.
