Mr. Wisner drew the Director's attention to his memorandum of 8 October on this subject which pointed out in part that in view of the publicity given this program it would appear it could no longer be considered a covert operation and, therefore, we should be off the hook once and for all. [redacted] undertook to again show the above-cited memorandum to the Director.

a. Reported that [redacted] would be briefed on our activities at 10:30 a.m. on 22 October, and, in fact, had agreed to spend the whole day with us if necessary. Mr. Amory undertook to get in touch with [redacted] and arrange a briefing for him on the overt side of the house.

b. Stated that Alexis Johnson had been appointed to a new post and had requested a briefing for himself and his successor, Mr. Everett F. Drumright. The DCI approved.

a. Reported that no reply had been received from Senator Saltonstall of our offer to brief him prior to his trip. However, he was expected in Washington shortly and Mr. Pforzheimer had been instructed to keep in touch with his office. The Director said he would like to see the Senator before his departure and stated that he should be briefed in [redacted]

b. Reported that Congressman Durham, a member of the Joint Committee on Atomic Energy, had expressed interest in receiving a briefing. The Director asked Mr. Kirkpatrick to have AD/SI clear this with Congressman Cole and if there was no objection to "go ahead".
