25X1 h. Referred to a cable [redacted] IN-43206, regarding releasing [redacted] and noted that High [redacted] had felt that he had been by-passed in this matter. Mr. Wisner explained the circumstances of the case. 25X1

25X1 i. Noted a cable from NAC announcing that the new organization was all set up. [redacted] and Mr. Wisner expressed certain reservations as to the command relationships established. It was decided to discuss this prior to [redacted] return. 25X1

25X1 j. Referred to the [redacted] debriefing and was informed that PP is using him at this time. When this is finished CIA will debrief [redacted]. The Director requested that when this is completed the whole matter be put together and given a very limited distribution. 25X1
