Mr. Dulles:

a. Noted he had received a call from Under Secretary of State Murphy who is most interested in finding and surfacing [redacted]. The Director said he was aware of the fact that we were working on this and asked DD/P to have the psychological warriors consider Mr. Kirkpatrick's suggestion that an offer of possibly \$100,000 be made for concrete evidence of [redacted] whereabouts and present activities.

b. Noted [redacted] was coming in to see him to discuss his status with the Agency. Colonel White said [redacted] was still on an LWOP status which was scheduled to terminate within the next thirty to sixty days. Mr. Dulles directed that steps be taken to terminate [redacted] and advise him that we would use him on an ad hoc basis in the future, as required. In connection with employees now on LWOP, the Director also asked that he be furnished a list of these people in view of the fact that such employees have the right to demand actual employment any time during the period they are in this status.

c. Raised the question as to whether [redacted] reported to the appropriate Deputies on actions taken at OCB Meetings, and upon being advised that in general he did, the Director stated he would make [redacted] responsible to do this as a matter of course and also designate him as the channel between CIA and the Executive Officer, OCB. [redacted]

Reported that at the OCB Meeting on 12 May it had been agreed that CIA would approach Secretary of Labor Mitchell respecting the forthcoming ILO Conference to be held in Geneva regarding representation in this organization by the Soviet and its Satellites as discussed at the Deputies' Meeting on Wednesday, 5 May 1954, and asked [redacted] to have [redacted] get in touch with Secretary Mitchell. Mr. Wisner noted he believed action on this matter had already been undertaken. In connection with this Conference, the Director stated the U.S. should be strongly represented and indicated that


