Mr. Dulles:

a. Asked [redacted] to call [redacted] and have him prepare a brief memorandum on what we intend to do with [redacted] in order that he might announce this at the IAC Meeting on 11 May.

b. Noted he had received a call from Admiral Radford this morning respecting [redacted] who might be of use to CIA in connection with our guerrilla warfare activities, and stated Admiral Radford had indicated that [redacted] was at one time an employee of the Agency, however, he (DCI) did not know him. Mr. Wisner verified that [redacted] had been with us at one time and reported in some detail on his activities while connected with the Agency. After some discussion it was agreed that DD/P would get in touch with [redacted] who is in Washington today, with a view to possibly using him again in Southeast Asia and in [redacted] particularly.
