a. Asked DD/I to provide him with a [redacted] report that the USSR had said they were prevented from aiding underdeveloped countries because of the US arms buildup.

d. Reported that he had a long talk with [redacted] who indicated to him that [redacted] runs the show.

Col. White recommended that the Director call Mr. Robertson at State and perhaps also Mr. Hollister. Mr. Amory pointed out the urgency of the matter and stated that per-

[redacted] that we had heard that [redacted] was not too much in the graces of [redacted] and asked that without reference to our understanding to the cause of this ask [redacted] to try to build him up and to destroy his reputation as a "no" man. The Director said he would take this up at a high level in the State Department.

Gen. Cabell said he had talked to Gordon Gray about this and that they would attempt to do something about it.

d. Said he had a report from Bill Godel and that the high brass in Defense was now leaning toward letting State or CIA chair the Countersubversion Committee.

Mr. Kirkpatrick:

a. Reported on the [] case and stated [] reversed his decision to resign after all possible explanations had been given him of the value to resign rather than be terminated. Stated a great deal of work had been done in this case and that since [] refused to resign, recommended he be terminated as of today by the Director. The Director asked those present if all approved and since there was no dissent he ordered the termination effective this date.

b. Asked if the Director wanted a documentary compiled on Congressional visits behind the Iron Curtain, or would it be satisfactory just to pull all material together in a central place. The Director approved the latter.

c. Reported that in connection with the manpower survey good progress was being made and that an interim report would be ready on schedule by the 15th of December. General Cabell asked that he be furnished this in draft form.

d. Said [] would be up for reassignment soon and wondered if we were interested in him. He has done one tour with the Agency. Mr. [] stated he is a good man and that we can always find a place for him but the time had come for [] to decide whether he wanted his career with [] or CIA. Mr. [] will talk with []
