DEPUTIES' MEETING

Wednesday, 1 August 1956

PRESENT: Mr. Dulles, General Cabell, Messrs. Wisner, Amory, Lloyd, Helms, Bissell, Sheldon (part of mtg.), General Truscott, [redacted]

Mr. Dulles:

a. Referred to Sukarno's speech before the Nationalist Party (PNI) at which he spoke in glowing terms of his recent trip to the US and stated that while it was State Department's business to do so, he felt this talk should be played up in the press at home and abroad. ACTION: DD/P to take this matter up with the appropriate people in State and USIA.

b. Noted he received a letter from Amb. Luce indicating that [redacted] a State Department employee, wants to join CIA. Mr. Dulles said he discussed this matter with [redacted]. Mr. Helms noted he was seeing [redacted] today and undertook to further discuss [redacted] possible employment. Note: The Director handed the Luce letter to COP.

General Cabell:

a. Noted General Doolittle had requested that Pete Scoville assume the Chairmanship of the Reconnaissance Panel of the Air Force Advisory Board. [redacted] is a member of this Panel). General Cabell said in his opinion there is a difference between our people serving as members of outside panels and being appointed as Chairman since such appointments actually, and in fact, involve direction and therefore both he and Dr. Scoville recommend that he (Scoville) not accept this appointment. ACTION: 1) DD/I to advise Dr. Scoville of the decision taken; 2) Dr. Scoville to inform General Doolittle it would be inappropriate for him (Scoville) to accept the Chairmanship of the Panel in question in view of the reason above.

b. Noted he received a letter from General Frederic E. Glantzberg, former Commanding General, 17th Air Force, highly praising [redacted] and said that General Glantzberg had indicated he could not have carried out his duties without the strong support furnished him by these two individuals. The Director asked that this letter be brought to the attention of [redacted] and made a part of their personnel records.

c. Referred to a recent Agency notice on supervision and noted he had received a number of good responses.

Mr. Wisner:

a. Noted we had now received comments from State and Defense on our satellite paper and it is intended we will incorporate all ^{of} State's comments with the exception of one which is being studied. Mr. Wisner stated this revised paper would reach the Director soon and he urged Mr. Dulles to find an opportunity to read it and furnish his comments before departing on his trip. Mr. Dulles indicated he would do this and Mr. Wisner commented that the Director might wish to place the paper in question before the OCB since it would not take much preparation on the part of the members -- Messrs. Jackson and Gordon Gray have read it as has Mr. Murphy of State and it can be assumed that he has or will bring it to the attention of Mr. Hoover.

b. Referred to discussions at recent Deputies' Meetings respecting Pakistan's proposal for a Southeast Asia food bank and noted we had been pursuing this rather vigorously, however, there was a certain amount of foot dragging on the part of the lower levels in State. The Director said if DD/P would furnish him a paper on this question he would place it before the OCB.
