MR. DULLES:

a. Referred to the receipt and distribution of National Security
Action Memoranda in the Agency and after some discussion it was agreed
that the current practice of these Memoranda being delivered to DD/I
and disseminated as appropriate by his office will remain in effect.
Mr. Bissell pointed out that with the movement of DD/I to the new
building, delay can be expected, and it was suggested that arrangements
might be made to have duplicates of these Memoranda delivered directly
to the DD/P. ACTION: DD/P and DD/I.

b. Noted that during his trip, [redacted] one of the DD/I
representatives in [redacted] had raised the question of furnishing more
intelligence material [redacted] in the estimative field and after some
discussion it was agreed to do this. The Director cautioned however that
NIEs as such should not be considered in this category and asked DD/I
to work the dissemination out with DD/P.



d. Reported on his meeting with the President's Foreign
Intelligence Advisory Board yesterday, and asked Mr. Kirkpatrick to
draw up a detailed memorandum of the points covered. The Director
also commented that Mr. Gordon Gray had raised the question whether
[redacted] receive KEYHOLE material and he had advised that
they did. Mr. Dulles said that apparently Gray had not been briefed on
this activity while he was a member of the Eisenhower administration
and asked Mr. Bissell to have Mr. Reber check the directives covering
limitations placed on eligibility to know about and receive the take from
this operation.

b. Reported that we had an opportunity to pick up 20,000 M-1 rifles at no cost other than rehabilitation which will run to about \$8.00 per rifle. The Director approved. Col. White noted that funds are on hand to pay for this expense.




MR. BISSELL:

Referred to Colonel White's memorandum of 15 September 1961 concerning Project [redacted] and in particular DD/S and Comptroller feeling that the Bureau of Budget in all probability will take the position that this project should be financed by re-programming. Mr. Bissell said that while he did not disagree with the DD/S opinion, he did feel that the time has about come that we should sit down with the Director of the Bureau of Budget and discuss the philosophy of releases from the Agency Reserve. After some discussion it was agreed that as a preliminary to this meeting, DD/P and DD/S would meet with Mr. Macy and pending the outcome arrange a meeting between the Director and Mr. Bell.


