MR. DULLES:

a. referred to reports that Trujillo was out of office and asked

question was also raised as to whether anything had been sent to the President in Paris on the situation in the Dominican Republic.

Mr. Sheldon left the meeting for a short period to advise Bromley Smith at the White House of the latest information received. It was agreed that anything that went forward to the President should include the statement that messages from the Dominican Republic are being censored and therefore [redacted]

b. Commented he had noted in the CIB of 29 May a report indicating the possibility that Zanzibar might go Communist. Mr. Sheldon pointed out that this could happen in the forthcoming elections. [redacted]

c. Stated his desire to see the two CIA officers who are now assigned to the White House International Situation Room. ACTION: Mr. Sheldon.

d. Referred to a cable to [redacted] and commented that while he was aware that this was a State message and was sent as received from the Department, he desired that in the future where the President is mentioned that a crypto be used or, if more applicable, a statement such as "highest quarters", "high authority," etc. ACTION: Mr. Helms

e. Referred to Chief, IOs proposed memorandum to the field pointing out that CIA should assiduously refrain from any dealings with the Peace Corps and after some discussion it was agreed that this memorandum should be dispatched provided a few changes are made, i. e. re-cast the memorandum to indicate it is of mutual interest to both CIA and representatives of the Peace Corps to stay apart; change the comment regarding Peace Corps employment and/or contact with former CIA employees; re-word the statement concerning the agreement between the Director and the Peace Corps Director, Mr. Schriver. The Director also commented it was not necessary for him to see this memorandum again.

MR. HELMS :

a. Referred to the article in today's New York Times by Raymond and asked if the Director could furnish any guidance and noted that he had already received several calls this morning. Mr. Dulles commented that it had been ~~mutually~~ agreed that in any future para-military operations where it becomes apparent that the operation could more easily be handled overtly or where the operation itself becomes overt, that such operations will be reviewed with the idea of being taken over by Defense or disposed of in some other way.

MR. KIRKPATRICK:

a. Reported that the President's Board would be meeting all day on Wednesday, 7 June and also that Dr. Killian had appointed Dr. ^{HYLAND} ~~Zand~~ to look into OSI and Dr. Langer will look into the activities of OCI.

b. Noted that the Agency had been requested to comment not later than today on a proposal establishing a Disarmament Agency. After some discussion it was agreed that our line should be that such an Agency does not relate to the mission of CIA or its functions and therefore we have no specific comments.

In this connection Mr. Kirkpatrick referred to our numerous attempts to obtain the files retained by General Donovan and stated that as reported previously, these files have a good deal of information which is still sensitive. The Director said he was aware of the efforts to obtain these documents and asked Mr. Kirkpatrick to get in touch with Mr. Houston and assert all the pressure possible to get these papers and file them in a safe place.

d. Recommended that something be sent to our Committees on the Hill regarding General Challe's statement as reported in today's Washington Post. The Director agreed but stated it would be better if we could obtain a transcript of the record rather than quote from the newspapers. ACTION: IG and Mr. Helms.
