DEPUTIES' MEETING

MR. DULLES:

a. The Director made the following report on his recent trip to Europe:

1. Keeping adjacent CIA Stations informed of the names of current Chiefs of Station

The Director noted that he had found that some of the European Stations had not been advised of the appointment of [REDACTED]. He said on the whole he felt it would be useful for adjacent Stations, unless there is some overriding security reason, to be kept informed of changes in the designation of Chiefs of Station.

2. Keeping the field better informed on what is going on at Headquarters

The Director said he had been particularly impressed by the need of some method of keeping field stations currently informed of major decisions, changes in policy, Congressional relations, publicity concerning the Agency, etc. He commented that the U-2 incident was a case in point and noted that at the time of his visit at some of the Stations, the Headquarters report on this matter was just arriving. It was pointed out that DD/S and DD/I send out monthly bulletins. However, by and large these publications only deal with matters of interest pertaining to these two components and the DD/I newsletter only goes to those Stations where he has representatives. In the discussion that followed as to how this matter can best be handled, Mr. Bissell stated that it appeared that the DD/P has the responsibility of keeping his people informed as is now being done by the DD/I and the DD/S -- particularly in view of the

25X1 large number of DD/P personnel serving overseas. It was agreed that DD/P will appoint a representative to consult with [redacted] of DD/I and [redacted] of DD/S and, from this discussion, devise a method of keeping field Stations informed along the lines indicated by the Director. The Director said he would be glad to meet with the committee if it were deemed necessary. Action: DD/P 25X1

The Director also commented that, in line with the above discussion, he had found that the supply of American publications in some of the field Stations visited is woefully lacking. He said it was his understanding that selected speeches made by him and General Cabell were being forwarded to the major Stations. However, when he had found it necessary to refer to his presentation to the [redacted] the Station had been unable to turn it up. Mr. Helms noted that this matter had been previously raised by the Director and he was sure that publications such as Foreign Affairs, Readers Digest, etc., are available and that the Director's more important speeches are being sent -- in any event, he said he would look into this. 25X1

3. Awards for ideas


The Director noted he was thoroughly familiar with the awards program but had the impression that by and large these awards are given for technical suggestions rather than substantive ideas and/or suggestions that will assist CIA in its operational and intelligence-gathering activities. He said he realized such ideas are difficult to define; however, he desired that action be taken to follow up on this subject.

6. Contact with USIA

The Director said that he believed it would be helpful if our field Stations, where appropriate, maintained closer contact with USIA representatives. He noted there might be problems in accomplishing this; however, we should have some idea as to the lines that agency is taking in its propaganda effort. Action: DD/P

c. Stated he had read the terms of reference for Mr. Kirkpatrick's Joint Study Group, and concurred with them. He noted his intention of discussing this matter with Stans of BOB whom he is to see this afternoon. He indicated that, based on the results of this discussion, he would speak to Gordon Gray and ask him to advise the President as to how it is proposed this committee is to proceed. In the meantime, the Director stated he saw no reason the committee cannot go ahead.

d. Noted a cable from Ambassador Byroade indicating that Afghanistan is about to go down the drain, and asked Abbot Smith to furnish him a Board memorandum on this situation.

DEPUTIES' MEETING

GENERAL CABELL:

a. Noted that Mr. Macy of the Bureau of the Budget had recommended that a study be made to (1) fix the blame for the causes of the recent riots in [Redacted] and (2) what action should be taken to prevent future incidents of this nature. Considerable discussion was held as to (1) timing of such an estimate, (2) its terms of reference, and (3) whether or not this study should be prepared by USIB. It was agreed that, as a starter, Mr. Kent would prepare the terms of reference for discussion with General Cabell on Monday, 27 June, and possible further discussion at the USIB meeting on 28 June.

b. Noted he had read with a great deal of interest the DD/P paper prepared on [Redacted] setting forth CIA assets in that country,

[Redacted] it had been prepared during his absence and he would like an opportunity to study it. General Cabell asked the DD/P that if he had any disagreement, to so advise him and, if not, to proceed as outlined in the paper. *jos*

d. Noted that at the request of the Vice President, a special meeting of the statutory members of the NSC (to include the Secretary of the Treasury) is being held today at 2:30 to receive a briefing on CIA activities in Cuba. General Cabell commented that Attorney General Rogers would be unable to attend and, therefore, Assistant

Attorney General Walsh would come in his place. Mr. Amory raised the question of whether Mr. Walsh should not be cleared for Special Intelligence, and it was agreed to do so provided the Attorney General concurs. *action. DOIT gsk*

MR. AMORY:

Reported that is proceeding with the drafting of a proposal that the photographs obtained from the AQUATONE operation be removed from the TALENT security channels and downgraded to Secret. General Cabell stated that while he had not yet seen the paper, he strongly felt it should contain two caveats: (1) there should never be assembled a compendium of all the photographs, and (2) the idea should be put across that the photographs released did not represent the bottom of the barrel and there were more to come. Mr. Kent commented that while he saw no objection to this proposal, he did feel that this material should remain Top Secret, pointing out that just yesterday Mr. Khrushchev stated the photographs obtained by the U-2 were of no consequence -- obviously the Soviets are concerned and would pay a high price to learn exactly what we have.

COLONEL WHITE:

a. Reported that we had submitted to the GAO for approval a new consolidated form covering requests for travel, advances, and travel vouchers, which had been concurred in by that office -- and in fact the GAO thought it so good they intend to recommend its adoption by several other government agencies.

b. Raised the question of concessions at the new building and noted in a preliminary talk with the Director it was more or less agreed that in view of the lack of space, it was a physical impossibility to provide for these facilities. After considerable discussion as to whether an effort should be made to provide for a drug store, barber shop, and a bank, it was agreed that (1) one barber would be provided who would be available on an appointment only basis, (2) the snack bars would stock simple pharmaceutical items, (3) the credit union will be available to cash checks.

MR. KIRKPATRICK:

Referred to the Kilday Committee's disappointment about the fact that it had never been briefed on the U-2 program prior to the 1 May incident, and noted it might be worthwhile to offer this Committee a briefing on other sensitive programs that might have a flap potential. After some discussion, it was agreed that Mr. Kirkpatrick, through Bob Smart, Chief Counsel, would offer in low key such a briefing, the contents of which will be decided if the briefing is accepted.
