At the meeting this morning the DCI established the policy that when a general snow emergency is declared whereby most Government Agencies are closed down and their employees are excused from work, the CIA must still maintain at least a limited staffing. Each Deputy will be responsible for making sure that every office within his area having sensitive and urgent requirements is staffed properly and adequately by competent personnel capable of carrying on all duties which may be required. Every effort should be made to assure that such personnel will be properly equipped with the necessary transportation aids to make sure they are mobile during difficult snow and ice conditions.



ACTION MEMORANDUM #7

TO: Mr. Bissell, Mr. Amory and Colonel White

After a discussion concerning the advisability of identifying various components of the Agency located in the new building with appropriate signs placed under the room numbers of the respective offices, the DDCI approved the following procedure:

There will be no uniformity throughout the Agency in the use of such identifying signs or symbols. It will be left to the discretion of each Deputy Director to approve what signs shall be put up in his respective area. The Office of Security will be consulted in an advisory capacity with no veto power prior to the erection of such identifying signs or symbols as are decided upon by the respective Deputies.
