At the U. S. Intelligence Board meeting of 27 January 1959, a progress report on [redacted] was presented by Army representatives. The purpose of the briefing was to acquaint the Board members with the status and future requirements of this [redacted]

As you are well aware, we are giving highest priority to the collection and analysis of information on Soviet ballistic missiles activities. We are counting much on this project which promises to yield valuable information. The U. S. Intelligence Board agreed on the feasibility and importance of moving ahead on the necessary scientific and operational improvements to the system.

Our review of this project indicated several steps which might be taken to bring the system to an early operational readiness. First, the full activation of the [redacted] field sites now projected, and any additional sites necessary to help to insure collection of data to identify [redacted] Soviet Union. In this regard, I am writing the Secretary of State urging prompt efforts to secure diplomatic clearance for the [redacted] site.
