The coroner and the police were most cooperative and made a very careful investigation. ~~They were assisted by my own people.~~ Both

I have also received independent medical opinion that in some cases the traces of poison are quite difficult to locate during autopsy.

In addition, there was no indication whatsoever that [Redacted] had company for dinner. The maid did report two glasses were on the table and she thought someone might have come in for a drink.

It is indeed hard to understand the motivation in these cases, and while I sympathize with your concern, I feel that from the wording of his note that your brother was obviously depressed and worried. His reasons for this may well have been personal, and I see no advantage to his memory to go further into them.


