

Dear John:

In regard to your request of August 23, 1962 for the assistance of the Atomic Energy Commission in providing U. S. weapons systems research data to a joint Central Intelligence Agency and Defense Intelligence Agency working group, the Commission shall be happy to provide the necessary information on the research being carried out under our programs.

As this will encompass several groups within the AEC, I have designated Mr. George B. Pleat, Deputy Director, Division of Intelligence, to act as a focal point within the AEC.
