Dear Mr. McCone:

I am very pleased to have accepted an invitation to be the Chairman of the National Health Agencies appeal among Federal civilian and military personnel. This will be the sixth year in which these national voluntary health organizations conduct this on-the-job drive.

The campaign here in the Washington area will be conducted during the six week period beginning March 1. I am told that campaigns of this type usually have to be extended in order to succeed because some agencies are not geared to take full advantage of the early part of the campaign period. I have asked the campaign office to make sure that we all have the materials and instructions which will enable every agency to get off to a fast start by March 1. I solicit your cooperation in seeing that your agency is organized to put the first part of the campaign to best use. In this way, perhaps we can establish another high mark in contributor participation and campaign income without the necessity of an extension period.
