Dear Mr. Bell:

With reference to your letter of 6 April 1962, we have reviewed the major programs and activities conducted by this Agency to identify trends which we believe may affect Government budgets through 1967.

The major goals and objectives of the Agency are determined by responsibilities imposed upon it by statute, by NSC directives, and from time to time by elements of the Government responsible for the formulation of policy such as the NSC Special Group. In projecting our budget estimates, we have assumed that these responsibilities will remain substantially unchanged. These include the coordination, collection, analysis and production of timely intelligence and the conduct of covert action programs in support of United States foreign policy objectives.

In general, we would expect increased emphasis over the five years on the Agency's programs for Latin America, particularly [redacted], [redacted] likewise, Agency programs in Africa and Southeast Asia will receive increasing resources from reprogramming.
