Dear Mr. Focke:

Mr. McCone has asked me to reply to your letter of 23 April 1962 concerning the proposed Executive Order assigning emergency preparedness functions to the Administrator of General Services.

We have reviewed this proposed order in terms of possible impact which it might have on our interests and responsibilities. In view of the highly sensitive nature of our mission and the resultant security requirements, we have been concerned over the consequences which might flow from having personnel of another agency working in our secure installations or in privacy with our communications facilities.

Representatives of our Agency discussed this matter in detail with Mr. Herbert Jasper and other members of your office and with Dr. Irvin Stewart and Mr. Fred Alexander of the Office of Emergency Planning at a meeting held on 5 June 1962. At this meeting conclusions were reached which, when applied to the wording of the proposed Executive Order, will effect the safeguards which we had in mind. We would, of course, like to review the amended draft prior to giving our formal concurrence.
