MEMORANDUM FOR: Director of Central Intelligence

SUBJECT : Nomination of [redacted] for the Third Annual Federal Woman's Award

STAT

1. This memorandum transmits for your signature a letter nominating [redacted] for the third annual Federal Woman's Award.

2. The attached letter from Mrs. Katie Louchheim, Chairman of the Board of Trustees, invites the Agency to nominate candidates for the Federal Woman's Award, which is given annually to six women in the Federal service. The previous recipients of these awards have been outstanding women whose careers represent remarkable achievements in domestic or international fields of Government service.

3. The Agency nominated [redacted] for the 1961 award and [redacted] for last year's award, but our nominees were not selected in the final determination of award winners. The Deputy Director (Intelligence) recommended that the Agency re-nominate [redacted] Deputy Chief, International Division. ORR for consideration for the 1963 Woman's Award. [redacted] Medical Staff, was also proposed as a potential candidate. The Personnel Advisory Board considered both of these outstanding and competent women and recommended that [redacted] be named again as our nominee. It was the consensus of the Board that [redacted] accomplishments in the field of international economics and the scope and significance of her activities are comparable to the careers of previous winners of the Woman's Award, and that it is appropriate to nominate her again this year. In making this determination, they considered her recent advancement to a higher organizational level and the fact that her work has involved interagency activity.

B. SUMMARY OF NOMINEE'S ACHIEVEMENTS

[Redacted] is nominated for the Federal Woman's Award because of the sustained excellent quality of her performance in the Central Intelligence Agency in producing and directing research on the international economic activities of the Sino-Soviet Bloc. [Redacted] enthusiasm, sound judgment, and dedication, combined with her outstanding professional and administrative abilities, have contributed greatly to the success of CIA's mission in the extremely critical and complex field of Sino-Soviet Bloc international activities and have resulted in providing significant information in support of policy decisions of the United States Government.

C. DETAILED STATEMENT OF BASIS FOR NOMINATION

Throughout her ten years of service in the Federal Government, [Redacted] has displayed outstanding ability, dedication to duty, and a sense of high purpose which is in the finest tradition of public service. As an economist with the President's Council of Economic Advisors, she was solely responsible for analysis of international economic problems. The President's Economic Report of December 1952, for the first time, carried an international economic relations chapter, which was prepared by [Redacted]

STAT [redacted] joined CIA in May 1954 and was assigned as an economic research analyst on Soviet Bloc economic activities. Despite quite limited initial knowledge of this field, she quickly grasped its essentials and rapidly turned out studies of the highest caliber which reflected an outstanding ability to perform economic analysis and to communicate her ideas effectively in writing. In subsequent assignments of increasingly greater responsibility, she has demonstrated high qualities of initiative, resourcefulness, and dependability, as well as unusual competence in the organization and the administration of research in the field of international trade and finance of the Sino-Soviet Bloc.

STAT [redacted] is admired and respected by her peers and subordinates alike, not only because of her intellectual qualities and her inspirational leadership, but also because of personal consideration and support which she extends to all of her associates.

The high regard in which the research on the economic activities of the Sino-Soviet Bloc is held by senior officials in CIA and the impact which the product has had upon government policy is testimony that [redacted] achievements in directing such research have been and are of great significance STAT to the mission of CIA and to the national security.

STAT [redacted] has ably represented CIA in various inter-agency groups, and has been highly praised by other participants for her thorough knowledge, her quick mind, her dedication, and her gracious manner.

In addition to her work in CIA, [redacted] has done considerable research and writing on her own time. She is STAT the author of [redacted] STAT

STAT [redacted] was part of a larger volume published by the National Bureau of Economic Research, and several articles and book reviews. She has also lectured before various women's groups and professional meetings.
