Dear Mr. McCone:

As you know, Government agencies from time to time make arrangements by charter or other contract with supplemental, nonscheduled carriers for transportation services. There have, unfortunately, been certain occasions upon which such a carrier has sought to operate without the certificate issued by this Agency as required by law. There have also been other instances where a certificated carrier has continued to operate pending proceedings designed to suspend or revoke its certificate because of failure to comply with standards imposed in the interest of aviation safety.

In order to give you additional protection in such circumstances, we suggest that you contact this Agency if you desire to charter or make other contractual arrangements for air transportation with a supplemental or nonscheduled carrier. We shall endeavor to give you a rapid and helpful response. Mr. George Prill, Director of our Flight Standards Service (Extension 4055) will serve as the Agency contact for this purpose.
