1. Following a request from headquarters on 21 Dec 61, arrangements were made to interview [redacted] at his home on Saturday, the 23rd. This was the first date [redacted] had open.

2. [redacted] former director and owner of the [redacted] in Havana, Cuba was arrested on 19 April 61. He was held at G-2 headquarters for one month, intensively interrogated and then transferred to La Cabana. There he was held until 5 Sept 61, although no formal charges were lodged against him.

3. Within two days after his arrest, and after G-2 officers had thoroughly searched and ransacked the records of his [redacted] he was requested to write out a detailed personal biography. This marked the beginning of a searching inquiry into his personal life. He was subjected to questioning for periods as long as twelve hours (1500 to 0300) in a soundproof, air-conditioned room behind the offices of G-2 headquarters. During these periods the interrogator sat at a desk which contained a hidden tape-recorder.

4. The theme of the interrogation always seemed to center on the notion that [redacted] was a US intelligence officer with ties to the FBI rather than to CIA. [redacted] was a long time employee of the US Federal government before his association with the [redacted] organization and his interrogators pressed this line hard. They told him it was quite logical and understandable that after such long service he would continue an "unofficial" relationship with the government and they tried to get him to uncover his local "network" (which he didn't have) and to reveal his communications technique for transmitting intelligence reports to his US "headquarters". ([redacted] was certain that non-Cubans were behind the analysis of the interrogation.)

5. [redacted] offers the following explanation as a possible background for this persistent line of questioning:

In March 1961, [redacted] made an emergency visit to the US. While he was here he discussed with the President

of [redacted] the fact that a pro-Castro situation was developing among his teachers in Havana. At the President's suggestion he, [redacted] called on the FBI and talked over the matter with an agent who had previously indicated curiosity over the political make-up of the [redacted] teaching staff in Cuba. [redacted] opines that his visit to the FBI at that time may have become known to the Cuban government. For example, his Cuban interrogators were particularly interested in the names and records of the teaching staff and wanted to know how each teacher felt about the Castro regime.

6. When [redacted] was transferred to La Cabana he found only one other US citizen there, a retired US army officer named [redacted] believed to be from Miami, Fla., went to Cuba in [redacted] 1960, for business reasons and was picked up at the airport in Havana on arrival. He was held incommunicado for 14 months at El Principe and is now serving a 14 year sentence at La Cabana on charges of being the head of the "White Rose" anti-Castro organization. [redacted] is desperately ill with kidney and liver ailments and receives no medical care. His physical condition has kept him from being transferred to the Isle of Pines.

7. [redacted] also heard, through the prison grapevine, that 16 US prisoners are languishing on the Isle of Pines. He was unable to develop any details bearing upon them.


8. Following his release on 5 Sept 61, [redacted] took refuge in the Swiss Embassy and remained there until his departure from Cuba in October 1961. He noted that he experienced a deep sense of insecurity during his sojourn at the Embassy and felt that he and others there could have been kidnapped by the Cubans had they so desired.





Dear Pres:

I have now received a report on [redacted] and find that Mr. [redacted] was arrested on 19 April 1961 in Havana and placed in the La Cabana Fortress, where he stayed until his release on 5 September 1961. Information received from other sources in the Fortress reveal that Mr. [redacted] was interrogated under glaring lights but was not physically mistreated otherwise. A source reported that while undergoing interrogation under these lights, Mr. [redacted] stated that he worked for U. S. Army Intelligence and the FBI.


