

Dear Bourke :

This is by way of follow-up on the two items you spoke to me about the other day.

Our people have advised me that we were first in touch with [redacted] when he visited in the Washington area briefly in 1949. We explored certain possibilities of employment with him in 1953 and again in 1956, at which time Allan Dulles had a personal talk with him. Nothing concrete materialized from these explorations, but I am having the appropriate officials look into the matter again as I understand his citizenship status and other factors presenting problems at that time may have changed for the better.

I have sent on to our personnel people the Form 57 which you gave me on Mr. [redacted]. They are writing to [redacted] and are reviewing the possibilities of employment with us.

I appreciate your interest in calling my attention to these two individuals.
