

As you know, both Senator Clinton O. Anderson and your uncle have written to Mr. McGee concerning your interest in employment with this Agency.

Your qualifications, as summarized in this correspondence and in your letter of 23 October to Senator Anderson, have been carefully considered by appropriate officials. We regret to advise you that there appears to be no opportunity for us to take advantage of your interest in working with us.

We have a continuing program to introduce into the Agency a few young people who are basically qualified for and interested in making their careers in intelligence work. This is but one element of a career service system providing for the development and competitive advancement of personnel. We are thus able to meet most of our requirements in the middle and upper grades through the assignment of a qualified career officer. Your qualifications have been examined in relation to current requirements for personnel which cannot be met by career personnel. The conclusion that there is no suitable opening for you does not reflect any lack of appreciation for your substantial background but rather the fact that there is no vacancy commensurate with your talents and abilities.

Your name has been noted for future reference and we shall of course advise you if an appropriate opening should develop. We do not have anything definite for you, however, and you should feel free to pursue your personal career without consideration of any possible future developments here.


Your thoughtful remarks about the importance of our work and your generous offer to be of service to us were appreciated.
