Dear Senator Sparkman:

Thank you for your letter of 2 May 1962 concerning

[Redacted]

[Redacted] was advised in March that she is surplus to our need for personnel in her career field and that her employment with the Agency might therefore be terminated in the next few months. This action was taken under a manpower control program established over a year ago and some thirty employees have been released from the Agency under similar circumstances during the past year. The determination that these individuals are surplus in their particular career fields was based on a number of factors, including their service history and potential for future usefulness to the Agency. Age was pertinent to this consideration but employees who are younger than [Redacted] and some who are older than she have been included in the group determined to be surplus in her career field.

In the case of [Redacted] as well as in the cases of all other employees who have received similar notifications, every effort has been made to place them in other career fields in the Agency and they have been offered assistance in seeking other employment.

Your inquiry on behalf of [Redacted] is appreciated and I hope that the information provided above clarifies her status.

Recently, I talked with [redacted] who is one
of your employees.

that she may be dropped from employment by your agency.

In talking with [redacted], I was impressed by her apparent
capabilities and the earnestness with which she approaches her work.
I am sure she has been a valuable employee in the organization.

I was also impressed by the fact that [redacted] is approach-
ing an age at which she might find it difficult to locate satisfactory
employment with another agency or with private industry. This causes
me concern. It does not seem fair or appropriate that an agency which
does not confer status on its employees should release them on the basis
of their age. In any event, I hope you will give most careful con-
sideration to [redacted] and her situation.

Remarks [Redacted] joined CIA 2 Apr 51 as a GS-3 clerk; she is now a GS-9 Operations Officer in the Soviet Russia Division. Her Fitness Reports have varied between 3 and 4 on a 6-point scale. After she was declared surplus to the Clandestine Services Career Service, [Redacted] reassignment to the Offices of Basic Intelligence and of Central Reference and to Foreign Documents Division (all in the Office of the Deputy Director/Intelligence) was considered but no suitable opening was found. [Redacted] is 54 years old. She had only 15 months of Government service prior to joining CIA and is not eligible for an immediate annuity. She will qualify for separation compensation of \$6,500 upon termination. [Signature]
