Dear Senator Byrd:

Thank you for your letter of 26 April 1962 concerning the status of [redacted].

[redacted] is, as you indicate, among the employees who have been found surplus to their career field and who have been notified that their services may be terminated under our manpower control program. He and the other members of this group are being considered for reassignment elsewhere in the Agency. They have records of productive and useful service and I sincerely hope to keep as many of them in the Agency as we can effectively assign to available positions. You may be sure that a conscientious effort is being made to do so.

If it should become necessary to terminate [redacted] employment, he will be eligible for a maximum separation compensation allowance of \$12,990. This is payable in an initial installment of \$4,332 upon termination and in subsequent bimonthly installments of not more than \$2,166 beginning six months after the initial payment and continuing until the balance of his allowance has been expended or eighteen months have elapsed since his termination, whichever occurs first. This allowance is intended to assist individuals who may experience difficulty in relocating in other suitable employment and assures them of income equal to at least two-thirds of their Agency salary during a period of vocational readjustment.

The interest you have taken in [redacted] is appreciated and in closing I want to assure you again that he will receive every consideration for reassignment.

Prior to coming to CIA, [redacted] was in the hotel business for several years except for a period in 1941-43 when he served in the Army. He is a Lt. Colonel in the U. S. Army Reserve. His file has been considered by the National Photo Interpretation Center and by the office of the Deputy Director (Intelligence) for general DD/I vacancies and by the Office of Training. No suitable opening has been found for him. He will be eligible for a discontinued service annuity in three years if he is retained.
