

We have carefully considered [redacted] thoughtful analysis of his background in relation to his potential contribution and have reviewed with interest the impressive file which accompanied his letter. He appears to be a man of intelligence and accomplishment who has a keen interest in this country's problems and a patriotic desire to contribute to their solution. We can readily understand that he seeks a role of leadership in the area where he feels he can make the most meaningful contribution. After serious consideration, we have been unable to identify an appropriate opportunity to take full advantage of his generous offer within the framework of our present activities. However, you may wish to bring this material to the attention of the Department of State in connection with the Department's responsibilities in the new inter-agency structure for Cuban affairs.

Your referral of [redacted] correspondence was appreciated. We are returning his papers herewith as you requested. If you should communicate with him concerning our review of this material, we hope that you will mention our appreciation for his thoughtful interest and our regret that we are unable at this time to make direct application of his talents and abilities in our service.
