**MEMORANDUM FOR: Deputy Director of Central Intelligence**

**SUBJECT: Assistance to the Joint Economic Committee**

1. This memorandum is for the information of the Deputy Director of Central Intelligence.

2. You will recall that last Spring, Representative Wright Patman, Chairman of the Joint Economic Committee, asked this Agency to again assist his Committee by contributing research papers on various aspects of the Soviet economy.



4. Preparation of the CIA studies was accomplished by ten ORR employees with the expenditure of a substantial number of man-hours. While most of the material was a matter of record in ORR, the analysis undertaken for these studies also contributed to the preparation of the forthcoming National Intelligence Estimate on "Trends in the Soviet Economy." Much of the time was spent in reducing these studies to the narrative form requested by the Committee and in preparing the material in unclassified form.

5. I have been in touch with Mr. Stark, Chief Clerk of the Joint Economic Committee, who has advised me that, as in the past, the Agency has made a substantial contribution to the Committee's work in the preparation of these studies for hearings which will be held on 10 and 11 December.

Our work on this project is now completed.
