

Thank you for your letter of 8 July concerning the application of Mr. [redacted] for employment with us.

STAT

Mr. [redacted]'s sincere interest in service with us was evident in his contacts with us and we can appreciate his desire to obtain further information concerning the reasons why he was not offered employment. As was explained in our letter of 21 May 1963 to him, however, this decision was based on a number of considerations, none of which was of itself compelling, and it is difficult to enumerate specific reasons.

We employ a number of communications personnel and Mr. [redacted]'s experience in this field of work was of interest to us. The conditions under which these people are employed, which not infrequently involve duty at isolated posts and under hardship conditions, make it necessary for us to apply severe standards with respect to the technical and personal qualifications of candidates for this work and the final selection process is highly competitive. In the overall evaluation of Mr. [redacted] against the broad range of requirements to be considered, it was our determination that he was not fully qualified.
