Dear Mr. Osmera:

Thank you for your letter of 21 November regarding an inquiry which you received from Mr. [redacted]

Mr. [redacted] wrote to our Personnel Office on 6 October 1963 indicating his interest in Agency employment. Our application forms were sent to him but, as yet, they have not been returned.

You mentioned in your letter to Mr. [redacted] that he has a German wife. If [redacted] is not a United States citizen, the employment possibilities for which we could consider her husband would be limited. We do not generally consider for staff employment any applicant who is married to a foreign national. However, we might consider Mr. [redacted] for employment in some other capacity.

You also referred to Mr. [redacted] interest in training possibilities with our organization. The Agency does have an extensive training program including language training for employees who have the basic qualifications for employment with us. It is doubtful, however, that the training which Mr. [redacted] might receive, if employed, would be of such a nature as to complete his general college education. We have a number of employees who attend local universities at night but this is on their own initiative and at their own expense.

We appreciate your bringing Mr. [redacted] inquiry to our attention and hope that the information supplied above will be helpful to you in responding to his request.



Dear Clint:

Ralph Dungan has sent me a copy of your letter of 12 November to Lawrence O'Brien regarding the recruitment of Spanish-speaking people. I certainly agree with you regarding the importance of sending to Latin America representatives who understand the language and customs of these countries.

The Central Intelligence Agency is regularly recruiting throughout the Southwest states, including of course the State of New Mexico; for example, we have a field representative who regularly visits University of New Mexico, New Mexico State University, New Mexico Highlands University, and Eastern New Mexico University. We recently sponsored at the New Mexico State University and the University of New Mexico meetings which were attended by a number of department heads, professors, placement officers, and administrative officers of those Universities. At these meetings, a senior officer of this Agency acquainted his University audience with the Agency's role in national security and the wide variety of professional skills required to support its mission. This program is directed, of course, at filtering down to the promising student, through his faculty advisors, information about the career opportunities that exist in the Agency and the importance, incidentally, of a facility in foreign languages. In addition, we have in recent years conducted a continuing clerical recruitment program in the Southwestern United States for Spanish-speaking applicants. Our recruitment in this area has been supported by public advertising and we have been accorded the use of the facilities of the various state employment offices.

If you should know of any good candidates for our work, I hope you will let me know about them.




