Dear Mr. McCone:

A small working committee, known as the Federal Committee for Security Equipment was activated informally on October 28, 1953 to serve in an advisory capacity to the General Services Administration in the development of specifications for security equipment. As a direct result of that committee's efforts, the GSA Federal Supply Schedule now offers the best security cabinets available. However, design changes and development of new security systems, together with techniques devised to render them ineffective, will require the efforts of an interagency committee on a continuing basis to ensure a level of protection commensurate with current security requirements. Accordingly, an Interagency Advisory Committee on Security Equipment has been formally established to discharge this function.

The purpose of the committee is to assist GSA in developing and maintaining specifications, standards, and test requirements for security equipment, including security filing cabinets, alarm systems, document destruction equipment, and related items, and to evaluate results of inspections and tests of such equipment. The activities of the committee will be performed under the direction of the Commissioner, Federal Supply Service. The Director, Standardization Division, FSS, has been designated to serve as chairman of the committee. In addition to the Central Intelligence Agency the following other departments and agencies having a primary concern in this program are being invited to name a representative:
