Dear Mr. McCone:

Recently the jurisdiction of Inspection has been broadened to include the investigations of attempted bribery, which necessitates the expanded use of technical investigative aids on a nation-wide basis. We, therefore, are establishing our own technical investigative aids training program. In order to develop the highest standards of training possible, we are seeking training outside our service in positive and defensive electronic techniques for Inspector Bruce E. Hipkins, who is our National Office representative in this field.

Inspector Hipkins has been processed pursuant to E. O. 10450 and Treasury Department Order #82, Revised, and is authorized to perform certain duties requiring access to classified information, and in connection therewith, is granted access on a need to know basis to such information up to and including TOP SECRET.

It would be greatly appreciated if you would assist us through any top-level training program you might have available for Inspector Hipkins.
