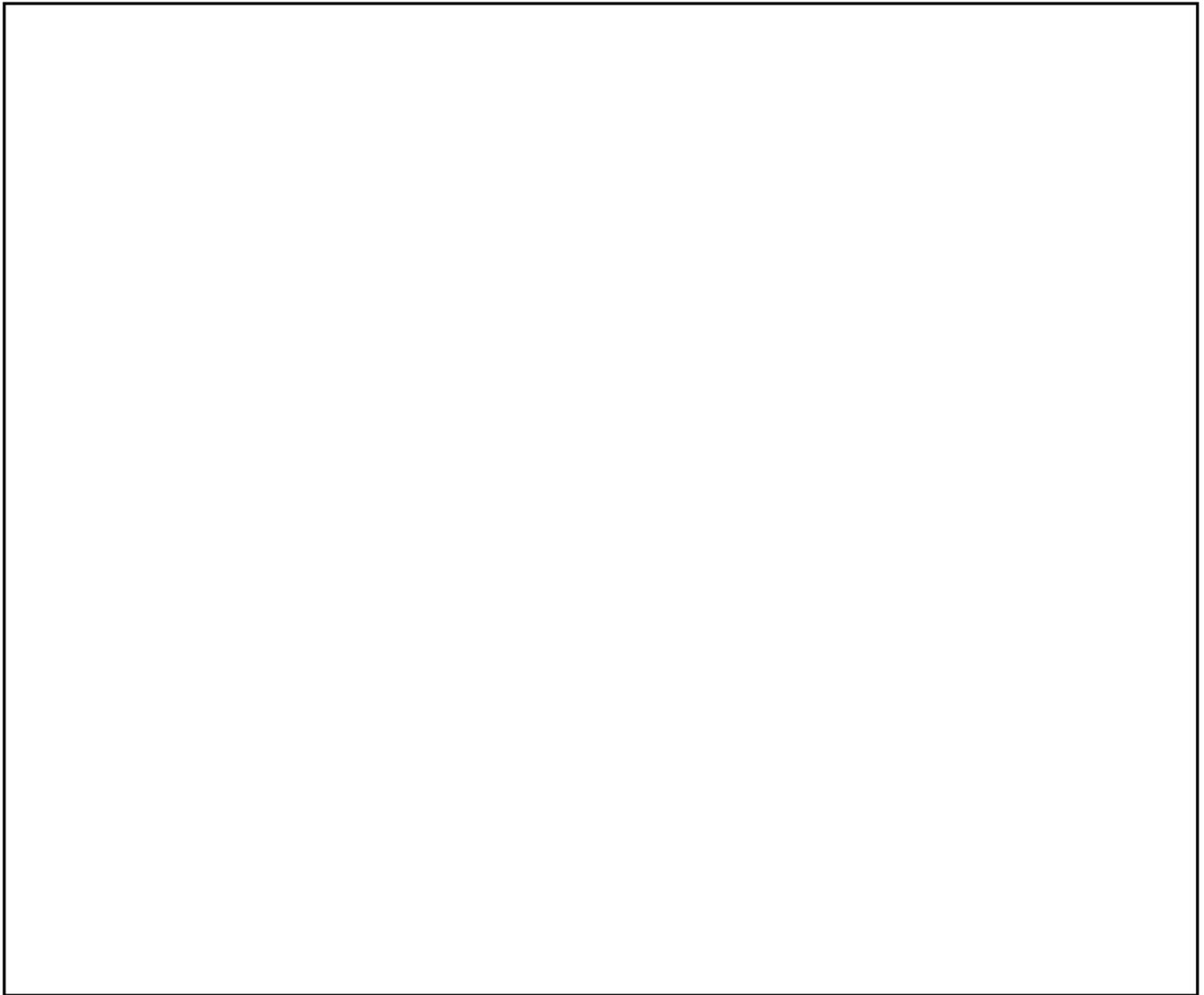

1. In response to reference (b), all other USIB members, by vote sheet action, have advised the Secretariat of their concurrence in the CODIB recommendation in reference (a) that USIB approve the policy statement on machine language preparation for index and reference collections set forth in paragraphs 3. a. through 3. d. of the attachment thereto (see Tab A).

2. The concurrences of the Army, FBI, and AEC members of the Board, as received by the Secretariat, were subject, however, to comments, and these are quoted for information in Tab B.

3. Your attention is invited to the briefing acts and recommendation of Mr. Borel on this matter (attached hereto as Tab C). Mr. Borel has advised, in addition, that the comments of the FBI and AEC members do not represent disagreement by those agencies in the objectives of the proposed policy statement, but reflect in his view individual agency difficulties in achieving complete and uniform implementation of USIB policy in this field.

4. Your approval, as Chairman, USIB, of the CODIB recommendation is required and hereby requested to complete Intelligence

Comments of Army, FBI, and AEC Members of USIB on

USIB-D-39.5/14

1. Army

"The current ACSI-MATIC conversion of files to machine language (punch cards and Flexowriter tapes) is considered partial implementation of the policy here established."

2. FBI

"FBI is unable at present to take positive steps toward automation of our records for budgetary reasons."

3. AEC

(Following statements keyed to specific paragraphs of the proposed policy statement)

"3. a. In the ADP installation being considered within the AEC for overall AEC operation, the AEC will not use internally consistent formats for entries. However, it is planned that the entries from the intelligence standpoint will provide a means for consistency with the intelligence subject code of the intelligence community.

"3. c. Since the AEC is in the process of developing an internal ADP system, this is not feasible.

"3. d. It will not be possible to make the entire AEC system compatible with the program of the intelligence community. However, the Division of Intelligence will do everything possible with regard to its functions to insure as much compatibility as possible.

"At the CODIB meeting of June 14, 1962, CODIB was made aware of the AEC ADP program as of the present time. Representatives of CODIB were invited to work with us to the extent possible in order to maximize the compatibility of intelligence interest to the AEC system."
