MEMORANDUM FOR THE CHAIRMAN, UNITED STATES INTELLIGENCE BOARD

SUBJECT: Requirements Guidance for High-Level Reconnaissance of Cuba

1. The attached memorandum reports that, after consultation with the Director, Defense Intelligence Agency, the Secretary of Defense has now agreed with the USIB requirement for weekly coverage of the entire Island of Cuba (weather permitting), rather than his previous requirement for daily coverage of the major military encampments.

2. As indicated in paragraph 2 of the attached memorandum, this now makes possible consideration of means for developing improved procedures for handling day-to-day targeting arrangements between COMOR and SAC, which you planned to undertake as stated in the 24 April USIB Meeting.

3. With your approval, I propose that the attached memorandum be circulated to USIB for information and referred to the Chairman, COMOR to consider and report on means for developing improved procedures referred to in paragraph 2 above.


