MEMORANDUM FOR CHAIRMAN, UNITED STATES INTELLIGENCE BOARD

SUBJECT: Forthcoming Meeting of AIM Panel Under GMAIC Auspices

1. This memorandum requests your decision as to the arrangements mentioned in paragraph 3. below.

2. As agreed by USIB at its 11 September meeting, an ad hoc technical panel has been set up under GMAIC auspices to study the AIM problem prior to USIB consideration of the Memorandum to Holders of NIE 11-3-63. This AIM Panel, the members of which are shown in the attachment hereto, will meet here on 24, 25 and 26 October. Their schedule is generally as follows:

a. Begin their sessions at 0900 Thursday, 24 October and continue them through Friday, 25 October.

b. Devote Saturday morning, 26 October, to completion of their written report.

3. [redacted] and Colonel Harvey, representing GMAIC, have requested your decision regarding the following arrangements:

a. They recommend, if possible, that you greet the AIM Panel briefly at 0845 Thursday, 24 October in a suitable location near your office on the 7th Floor.

b. They question whether you wish a meeting of USIB with the AIM Panel on Saturday afternoon, 26 October, but do not recommend such a USIB meeting since the Panel will be submitting to USIB a written report.

c. Alternatively to a USIB meeting, they suggest the possibility of your meeting with the AIM Panel either in the late morning or for lunch on Saturday, 26 October.
