Dear John:

I would like officially to commend your station chief in Saigon, [redacted]

As you know, I first visited Saigon just a year ago immediately following a United States decision to support the Vietnamese Government in its struggle against the organized Communist terrorism there. [redacted] took over the station just as this support began to arrive and just as the Vietnamese embarked on the strategic hamlet and Montagnard programs. Just one year later, in January of this year, I visited Saigon again. There was, in the intervening months, an enormous improvement in the situation in which your organization played a very significant role. Much of the credit for the improvement in the situation belongs to [redacted] especially in the [redacted] program and in the vastly improved intelligence that the government forces are now receiving about Viet Cong activities.

I would be grateful if a copy of this letter could be put in [redacted] personnel file.
